

Minutes of RSGB VHFCC Meeting (Audio Conference) Friday 9th March

Attendees: G4PIQ (Chair), G0FCT, G0GJV, G3YSX (Board Liaison), G4CLA, G4HGI, GD8EXI, GM8IEM, G8TIC

Apologies for absence: G3XDY

- 1. Activity Review
 - 1.1. A review of entry levels during the 2017 season was undertaken and is attached at Appendix A.
 - 1.2. UKAC entry levels remained very healthy with 2m, 70cm and 23cm remaining broadly flat. There was around a 15% decline on 50 MHz, and around a 15% rise on 70 MHz and a 25% rise in the SHF events.
 - 1.3. Most of the Weekend events are also in growth, particularly the 6m Trophy, 2m Trophy and many 4m contests. There are also some exceptions –
 - 1.4. May and October UHF events & 1.3 / 2.3 / 10 GHz Trophies these are specialist events but are not growing. We will see if the inclusion of the 10 GHz Trophy within the VHF Championship this year has any effect
 - 1.5. 4m and 6m CW events these have plateaued at a low level
 - 1.6. There was also a reduction in entry levels to the 6m AFS for the first time in several years
 - 1.7. The Christmas Cumulative Contests also declined this year
 - 1.8. Activity for 2018 has so far been affected by weather, but it is too early to draw any overall conclusions about overall activity levels although GM8IEM raised a concern that activity may be declining in GM this year.
 - 1.9. Not all the events are recorded in the tracker.
 - 1.10. There was a discussion around whether we were now running too many contests as we continue to add events to the calendar, but remove few, causing a dilution in activity levels. We agreed to keep entry levels under monitoring and review the calendar for 2019.
 - 1.11. We recognised that we should look more widely at what was happening to European activity levels and the numbers of QSOs made to Europe within the Tuesday night events.
 - 1.12. MGM activity appears to be increasing we would hope this will flow into the MGM contests to be held later in the year
 - 1.13. There continues to be a fair amount of discussion around the use of KST, but both sides of the discussion are well represented. We will review the impact of the experimental changes to Low Power and Backpackers later in the year.
 - 1.14. FMAC does not appear to be meeting its aims of engaging new contesters it remains very much a UKAC warm-up event. We need to try and get the publicity out to clubs that it exists.
 - 1.15. We should also carry out an analysis to see how many people have gone from FMAC -> UKAC, or any from UKAC -> FMAC during the contest lifetime.

Action: G4PIQ to add SHF UKAC, FMAC and VHF NFD sweepers to the tracker Action: G4PIQ to run analysis of FMAC -> UKAC and UKAC -> FMAC movement Action: G4PIQ to organise for a UKAC message to go out to clubs

- 2. GDPR
 - 2.1. The GDPR regulations which come into force in May 2018 will have implications for the society and for the operation of the committee but the issues will primarily fall within the remit of the CSC. Thank you to Mike, G8TIC for a valuable brief on the subject.



- 2.2. There will be a meeting on this subject with the lead board member prior to the Leadership Team meeting on Saturday 17th March.
 - Action: G0FCT to draft actions required
- 3. Celtic Knot
 - 3.1. The operation of the GMDX Celtic Knot competition was discussed, and it was recognised that the event is not under control of the RSGB - it is consuming public domain data published by the committee.
 - 3.2. We welcomed the operation by GMDX of an opt-out scheme for stations not wishing to take part in the GMDX event.
 - 3.3. We also provided a suggestion to GMDX around the naming of their sections. Any GDPR requirements will be managed within the GDPR activity. Action: G0FCT to review for GDPR implications Action: GM8IEM to feedback comments / suggestions to GMDX
- 4. MGM Contest
 - 4.1. The first MGM contest is fast approaching.
 - 4.2. It is interesting to note that casual FT8 activity on 2m looks to be showing up a whole new group of stations who aren't well known on the band. It maybe that MGM is actually the area where we are more likely to pick up new contesters.
 - 4.3. Richard, G4HGI has been busy promoting the event across Europe with all the Region 1 VHF Managers e-mailed. Ian, G0FCT has also put it in for inclusion within the next IARU Region 1 Contest Newsletter. More publicity is good. Action: All to promote the MGM contests wherever possible
- 5. Trophies
 - 5.1. The contest committees are currently reviewing what to do with trophies as a result of logistical challenges at HQ – the trophies are taking more than the available storage space.
 - 5.2. VHFCC agreed that trophies were an important incentive in encouraging regular entries and in having clubs encourage as many of their members to come on as possible.
 - 5.3. There are a number of contests where we would like to award trophies where we currently don't, and we have had offers of donation which have been placed on hold pending getting to a position where we know how we can manage these additional trophies.
 - 5.4. It was recognised as important that we have a common policy across HF and VHF contests.

Action: G4PIQ and G0FCT to meet with RSGB GM and G4FAL to agree a way forwards

6. Publicity

- 6.1. Publicity remains one of the areas where we need to do much more. G4PIQ has had offers of help but has held off on the basis that it would be better to have a common approach across both HF and VHF, but it is now important that we move this on.
- 6.2. There are multiple channels which we need to co-ordinate and actively manage and develop a strategy. The Facebook group now has 1105 members for example. There are also the Groups.io reflector and the e-mail newsletters.
- 6.3. We should use Heather @ HQ for PR via the formal RSGB channels where possible and as appropriate – given appropriate notice (3 weeks ideally)
- 6.4. GM8IEM can also address the GMDX lists
- 6.5. There is still an audience which only reads Rad Com so we need to use this as well
- 6.6. We also need to engage via club contacts, regional managers Action: G4PIQ to agree a publicity strategy with G4FAL and G0FCT and then approach volunteers
- 7. Rule Interpretation
 - 7.1. The committee discussed the situation where one society has been sharing their club station across multiple during the 23cm UKAC events. They appear to be complying with



the 15-minute rule and different stations are worked by each operator – so this feels like quite genuine operating within the current rules.

- 7.2. The details of the station sharing rule will be reviewed for 2019 based on 2018's activity.
- 7.3. A number of cases of rules being significantly stretched were discussed and appropriate monitoring / actions agreed
- 8. AOB
 - 8.1. We discussed whether we should include every calendar month in the UKACs for 2019 this will be for discussion under our wider rule setting agenda later in the year
 - 8.2. We discussed the issue of our 6-hour section definition being different to the IARU one and the issues that this causes. Our hope is that the new flexibility of our section + the recommended operating times element will improve weekend activity this year –we will monitor and review this.
 - 8.3. Ian, G0FCT will continue to provide feedback into the IARU group and promote our approach. Clearly success in improving our entry levels this year are good evidence of the benefits.
 - 8.4. We discussed meeting dates and that we currently do not have a regular evening meeting slot that all members can make. We need to get a schedule together which works for most of the people most of the time and rotate dates.
 Action: G4PIQ to create new meeting schedule
